On 20-3-2015("the date of the sale") :

Balloting will be used to determine the order of priority. The persons or companies incorporated in Hong Kong (companies not incorporated in Hong Kong are not eligible) interested in purchasing any of the specified residential properties (" the registrant(s) ") must follow the procedures below : —

1. Each of the registrants (if the registrant is a company incorporated in Hong Kong, then any one of its directors) must submit **personally**
 - (a) the Registration of Intent duly completed and signed by the registrant;
 - (b) one cashier order in the sum of HK\$150,000.- made payable to " WOO, KWAN, LEE & LO " ; and
 - (c) a copy of the registrant ' s H.K.I.D. Card(s) or Passport(s) (as the case may be) or copy of Business Registration Certificate, Certificate of Incorporation, Registers of Directors and the latest Annual Return of the registrant and the H.K.I.D. Card of the Director of the registrant (if applicable) to The Visionary Sales Office at 1/F., Octa Tower, 8 Lam Chak Street, Kowloon Bay, Kowloon (" The Visionary Sales Office ") from 2:00 p.m. to 3:30 p.m. on 20-3-2015 in order to register for eligibility to the balloting which shall take place at 5:00 p.m. on 20-3-2015.
2. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
3. The registrants who have submitted the registration in accordance with item 1 shall be eligible for the balloting.
4. The balloting will take place at The Visionary Sales Office at 5:00 p.m. on 20-3-2015 and the balloting will be effected by computer network. The ballot results, including "registration number", "ballot result sequence" and " the check-in timeslot for registrants " shall be posted at The Visionary Sales Office at 5:30 p.m. on 20-3-2015. The opening hours of The Visionary Sales Office on 20-3-2015 is from 11:00a.m. to 8:00p.m.
5. The registrants (if the registrant is a company incorporated in Hong Kong, then any one of its directors) shall personally attend The Visionary Sales Office on 20-3-2015 according to " the check-in timeslot for registrants " in the ballot results posted by the Agent appointed by the Vendor. The registrants must bring along their H.K.I.D. Card(s) or Passport(s) (as the case may be) or Business Registration Certificate, Certificate of Incorporation, Registers of Directors, the latest Annual Return of the registrant and H.K.I.D. Card of the Director of the registrant (if applicable) and the official receipt for the Registration of Intent. The registrants whose identities have been confirmed and verified by the Agent appointed by the Vendor shall be eligible to select the specified residential properties which are still available at the time of selection in the order of priority according to the ballot results. Registrants who arrive at The Visionary Sales Office at any time later than " the check-in timeslot for registrants " assigned in the ballot results on 20-3-2015 shall not be eligible to select the specified residential properties in the order of priority according to the ballot results and the registration of such registrant(s) will be deemed invalid.
6. Each Registration of Intent will be entitled to purchase 1 specified residential property only.
7. If a registrant has not purchased any residential property, his / her unused cashier order(s) will be available for collection by the registrant in person or by authorized person at The Visionary Sales Office from 23-3-2015 to 25-3-2015 (from

11:00a.m. to 8:00p.m.). The Registrant or the authorized person (if applicable) must bring along the original H.K.I.D. Card(s) / Passport(s) of the Registrant (or a copy of the H.K.I.D. 以抽籤方式決定優先次序，有意購買該等指明住宅物業的人士或在香港註冊成立的公司(不接受任何在香港以外註冊成立的公司)(下稱：登記人)須遵從下列程序：—

1. 登記人(如登記人為在香港註冊成立的公司，則任何一位董事)於2015年3月20日下午2時至下午3時30分須親臨九龍九龍灣臨澤街8號傲騰廣場1樓昇薈售樓處(下稱：昇薈售樓處)遞交：
 - (a) 已填妥及由登記人簽署的購樓意向登記表格，
 - (b) 一張港幣150,000元本票，抬頭人為「胡關李羅律師行」及，
 - (c) 登記人的香港身份證或(視屬何情況而定)護照或商業登記證書、公司註冊證書、董事名冊副本、最新的周年申報表和董事的香港身份證副本(如適用)，進行登記以取得參加2015年3月20日下午5時進行的抽籤程序的抽籤資格。
2. 已繳交之本票將會作為購買指明住宅物業的部份臨時訂金。
3. 已根據上述第1條進行登記的登記人可享有抽籤資格。
4. 抽籤程序將於2015年3月20日下午5時於昇薈售樓處進行，抽籤以電腦操作。抽籤結果，包括“登記號碼”、“抽籤結果順序”及“登記人報到時段”，將於2015年3月20日下午5時30分於昇薈售樓處公布。昇薈售樓處於2015年3月20日之開放時間為上午11時至晚上8時。
5. 登記人(如登記人為在香港註冊成立的公司，則任何一位董事)須於2015年3月20日按照賣方委託的代理所公布之抽籤結果中所指示的“登記人報到時段”攜同其香港身份證或(視屬何情況而定)護照或商業登記證書、公司註冊證書、董事名冊副本、最新的周年申報表和董事的香港身份證(如適用)及購樓意向登記表格的正式收據親臨昇薈售樓處，經賣方委託的代理確認並核實身份後方可有資格根據抽籤結果順序揀選於當時仍可供揀選的指明住宅物業。於2015年3月20日，抽籤結果中所指示“登記人報到時段”後才到達昇薈售樓處的登記人將被取消根據抽籤結果揀選指明住宅物業的資格，其登記將被視作無效。
6. 每份購樓意向登記只可認購1個指明住宅物業。
